☑ Environmental Policy Statement

Alexander & Cleaver strives to reduce its impact on the environment, because we believe it is our responsibility to leave a better Maryland for our children. Every member of our firm is not only dedicated to this mission, but honored to be a part of it.

✓ Environmental Team

The Environmental Team's mission is to fulfill Alexander & Cleaver's Environmental Policy by meeting monthly or as needed. The team further serves as a conduit to energy savings ideas generated by Alexander & Cleaver, P.A. team members. Team members include Matthew J. Youssef, Lyle Fowlkes and Teresa Fletcher.

Annual Environmental Goals

Our goals are broken into 3 categories: reduced energy usage, water efficiency and waste reduction through conscious efforts and sustainable practices. Alexander & Cleaver is committed to reducing energy consumption by 20%, shrinking water consumption by 10% and waste by 25%.

While the Environmental Team is constantly looking for new ideas, some of the most tangible goals are:

- Use both sides of all paper used for internal consumption;
- Use both sides of paper on as many presentations as appropriate;

- Utilize electronic drafts as much as possible to reduce overall paper consumption;
- Turn off lights, printers and unplug appliances not in use;
- Turning off lights of offices not in use;
- Replacing incandescent light bulbs with compact florescent bulbs;
- Recycling all recyclable waste;
- Eliminate the use of disposable plates and utensils, whenever possible and use recycled materials whenever necessary;
- Increase communications so that furniture is moved between offices to accommodate changes rather than disposing and repurchasing;
- Reduce facsimile communication whenever scan and email is possible; and
- Recycle all copier and printer toner.

☑ Environmentally Preferable Purchasing

Alexander & Cleaver, P.A. is committed to purchasing recycled and environmentally friendly products whenever such a decision is not cost prohibitive. Further, by reducing paper consumption, a portion of savings is used to purchase recycled paper.

Environmentally Preferable Products and Services

Alexander & Cleaver, P.A. counsels energy producers on Maryland's ever changing energy regulatory laws both in renewable energy and energy efficiency. It helps guide property owners and commercial tenants obtain LEED certifications, and connects valuable nonprofits with Maryland's elected officials to produce a cleaner environment.

<u>Waste</u>

Solid Waste Reduction and Reuse

Alexander & Cleaver P.A., reuses file folders, case jackets, accordion folders and paper until it is impractical to continue use, then they are recycled as

stated below. Our paper consumption has dropped from about fourteen cases of paper a month to ten cases of paper a month. According to the Environmental Defense Fund's Paper Calculator, this is an annual savings of 3 lbs of sulfur dioxide, 662 lbs of CO2, 2,453 gallons of waste water and 216 lbs of solid waste.

✓ Recycling

Alexander & Cleaver donates its entire outdated library to the Book Thing, Inc. in Baltimore with the hope that while the texts can no longer serve our clients, they may be re-used. It recycles office supplies, copier and printer toner, all paper, plastics and aluminum.

Energy

☑ Energy Efficiency

Alexander & Cleaver is replacing all lighting with energy efficient lights, as well as striving to rely on natural lighting whenever possible.

Whenever possible Alexander & Cleaver powers down its facility each night to the extent such action reduces energy demand. Fax machines, copiers and scanners are set on timers to power down when not in use.

Transportation

Efficient Business Travel

Alexander & Cleaver uses conference calls to eliminate inter-office travel and whenever possible coordinates court filings to eliminate unnecessary gas consumption. By more closely watching our attorney's trial schedules and interoffice travel we have been able to eliminate a clerk driving everyday from Fort Washington, MD to Annapolis, MD and back which is 84.4 miles per day round trip. Eliminating three of these trips per week is an annual savings of 599 gallons of gas, 81 lbs hydrocarbons, 606 lbs carbon monoxide, 12,060 lbs carbon dioxide, and 40.31 lbs total nitrous oxide.

Water

✓ Water Conservation

Alexander & Cleaver makes a consistent effort to reduce water consumption including but not limited to running the dishwasher at off-peak hours and only when full.
