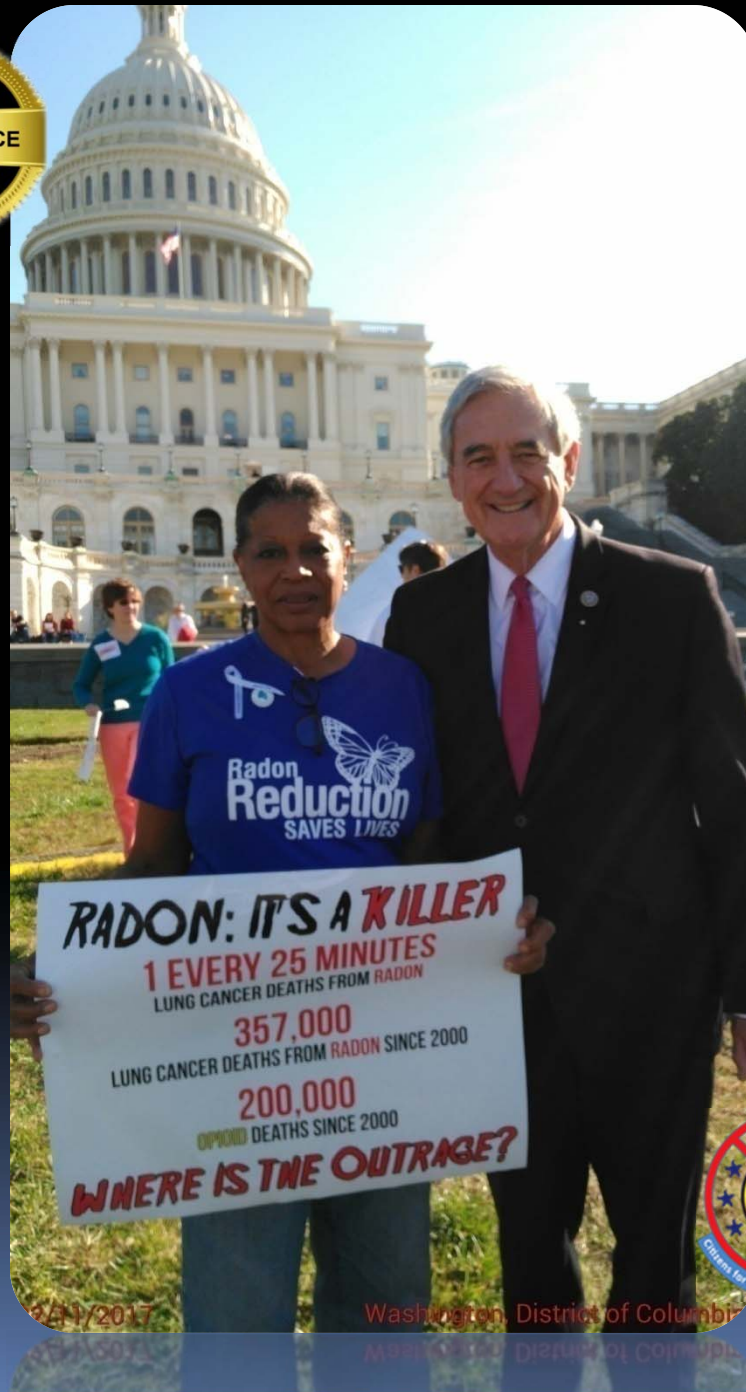


MISSION

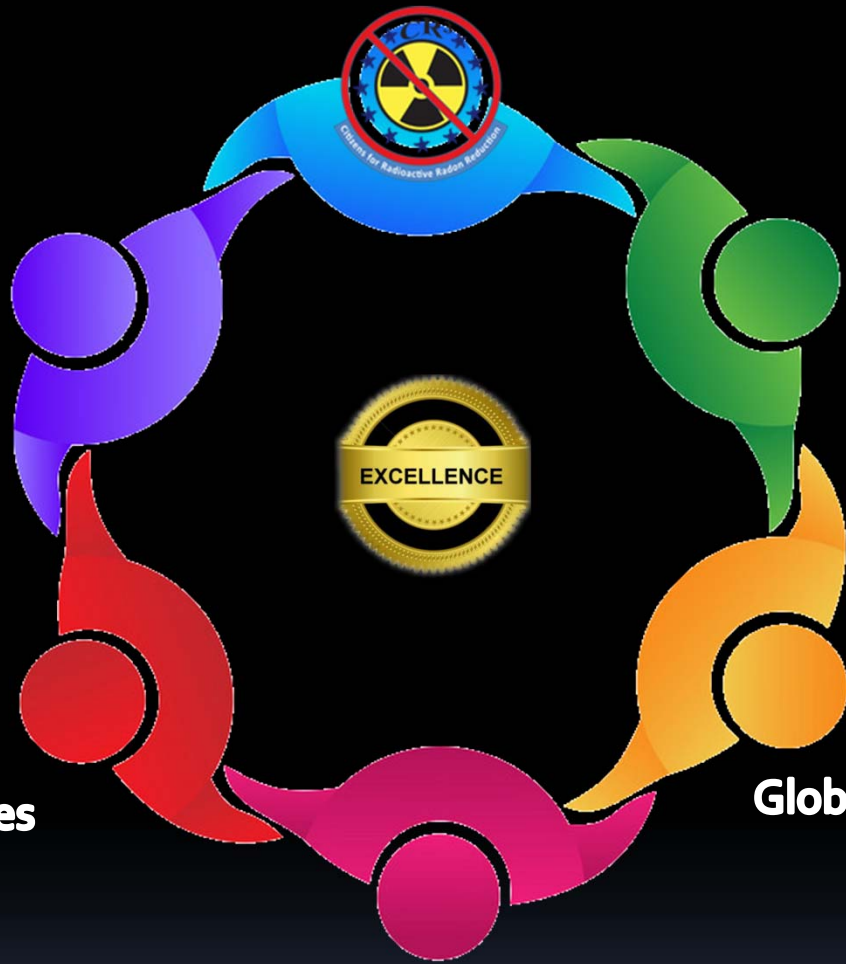

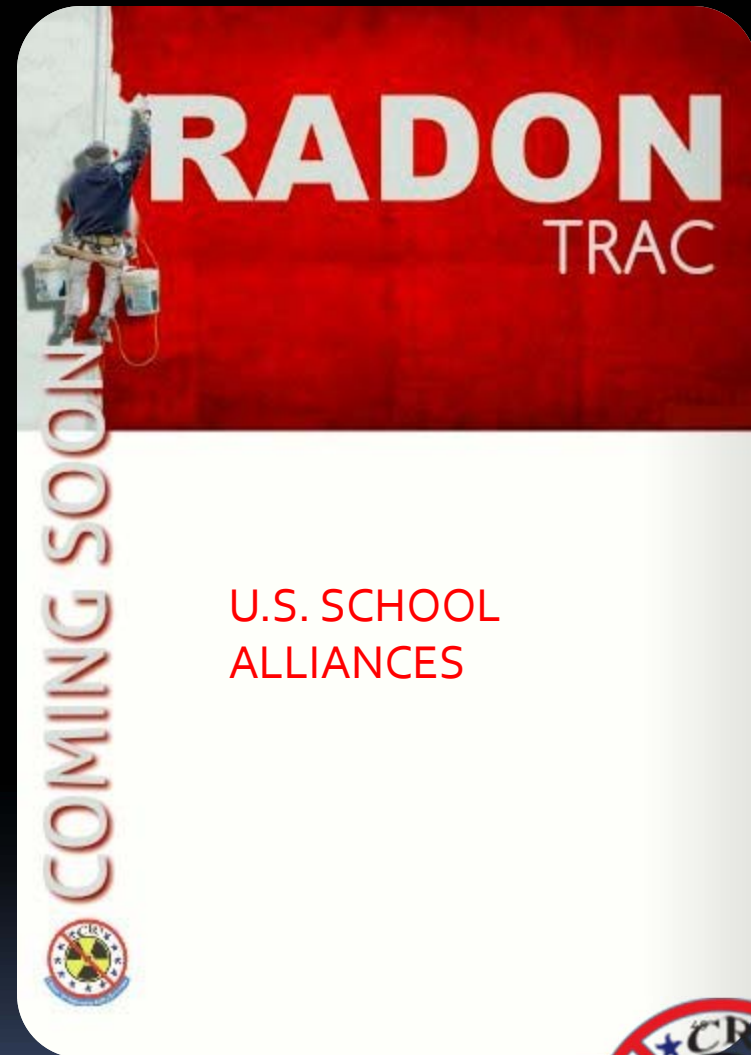


NEW “FOCUS” IN RADON ADVOCACY
