As requested by the Maryland Department of the Environment (MDE) in their December 29, 2009 directive letter, AECOM Environment (AECOM), on behalf of 7-Eleven, Inc. (7-Eleven), is submitting the attached potable well survey for a half-mile radius of the above-referenced property. Included in this submittal are a tabulation and a plot of well data obtained from a MDE Well Search Database program received on August 14, 2009 from MDE.

AECOM has also submitted a Public Information Act (PIA) Request for Information to the Harford County Health Department Bureau of Environmental Health for information on potable wells within a half-mile radius of the subject property. No response has been received from the County to date; any relevant data received from the County will be forwarded to MDE under separate cover.

Based on the data obtained through the well search, potable wells are located within a half-mile radius of the site in all directions, with the largest concentrations located to the northwest and southwest, greater than 1,000 feet from the site. Wells generally are identified as 6 inches in diameter, steel-cased down to at least 50 feet, with a total well depth greater than 150 feet.

AECOM is currently preparing a lineament analysis of the site for submittal to MDE by March 30, 2010. If you have any questions regarding the project, please contact the undersigned at 410-884-9280.

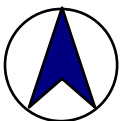
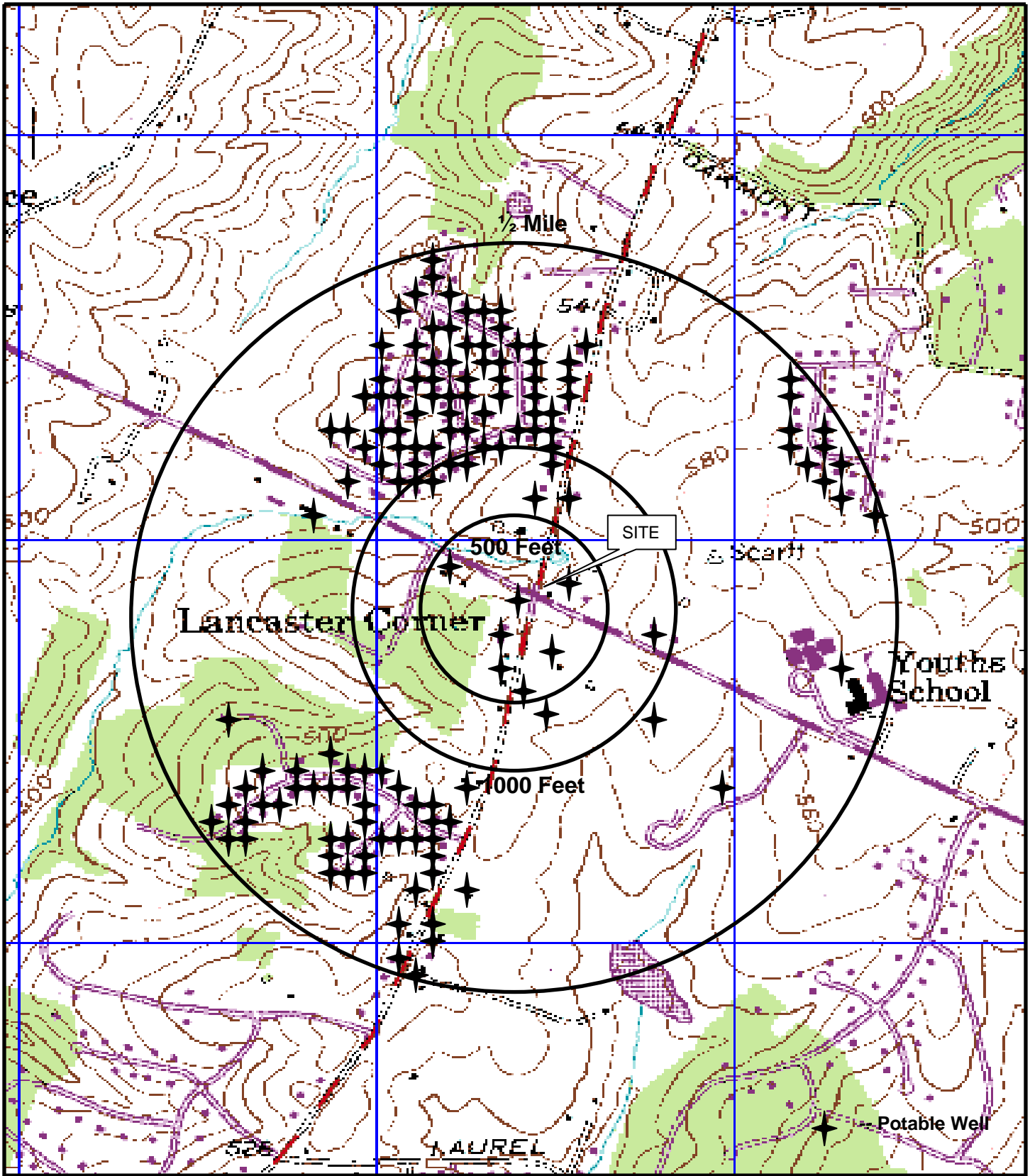
