



Expanded Polystyrene (EPS) Food Service Product Enforcement Contact Information

What You Need to Know

The Law

The EPS law prohibits any person from selling or offering for sale in the state an EPS food service product. It also prohibits a food service business or school from selling or providing food or beverages in EPS foam food service products. The law does not prohibit a person from storing an EPS food service product for later distribution outside Maryland (Environment Article, 9-2201 – 9-2207, Annotated Code of Maryland).

The EPS law requires counties to enforce the prohibition on EPS food service products. Each county may choose how to enforce the law, including through its local health department or environmental department. Counties are authorized to impose penalties of up to \$250 for violations, after written notice and an opportunity to correct the violation. County government shall notify the Department of any violation of § 9–2203 of this subtitle.
