- Grounds to Grow On recycling program for all components of a K-Cup to be repurposed and the coffee grounds composted. The program saved 382.7 pounds of cups from the landfill for 2018. While utilizing carbon neutral transportation with UPS.
- We recycle Plastic cups, bottles, and other plastic products (i.e. silverware)
- We recycle Paper
- We recycle old electronics

Energy Efficiency

- *Retrofit office with eco-friendly lights with motion sensitivity*
- Eco-friendly refrigeration devices. Reducing the electricity consumption of refrigeration units that are notorious energy hogs.
- Green Team Night Watch, members routinely turn off lights in unoccupied rooms and unused areas. (Daily)
- New office will utilize energy efficient smart outlets

Transportation

Employee Commute/Customer Travel

- We provide video conferencing and other technological solutions that reduce employee travel.
- We regularly distribute and provide display for information on transit, car/van pooling, and other commuting alternatives, including Guaranteed Ride Home and Regional Ride-Sharing programs.

 Guaranteed Ride Home provides commuters who regularly, carpool, vanpool, bike, walk, and take public transit a guaranteed ride home for unexpected emergencies. Up to 4 times per year.

• We target the encouragement of employees to work from home, bike, walk or use other non-carbon emitting forms of transportation at least once a week.
